Pursuant to section 4(b) of the Pro bono Work to Empower and Represent Act of 2018, also known as the "POWER Act," Public Law No. 115-237, the Director of the Administrative Office of the United States Courts is required no later than January 1 of each year to submit to Congress a compilation and summary of reports received from chief district judges detailing each public event conducted in accordance with the law's requirements during the previous fiscal year.

As detailed in the attached report, during fiscal year 2019 the Federal Judiciary led 100 public "empowerment" events in 86 judicial districts. These public events met the goals of the POWER Act by informing more than 7,000 attendees of the importance of pro bono work.
