**A BILL**

To prohibit United States cooperation with the International Criminal Court, the use of the Economic Support Fund to support the Palestinian Authority, and any Federal funding for the ICC.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Stop the ICC Act”.

5 **SEC. 2. PROHIBITION AGAINST COOPERATION WITH THE**

6 **INTERNATIONAL CRIMINAL COURT AND SUP-**

7 **PORT FOR THE PALESTINIAN AUTHORITY.**

8 (a) FINDINGS.—Congress finds the following:

1           (1) In 2014, and in each subsequent year, Con-  
2           gress has enacted provisions, including section  
3           7041(k)(2)(A)(i)(II) of the Further Consolidated  
4           Appropriations Act, 2024 (Public Law 118–47), pro-  
5           hibiting the use of economic support funds for the  
6           Palestinian Authority if the Palestinians initiate an  
7           investigation of the International Criminal Court  
8           (referred to in this section as the “ICC”), or actively  
9           support such an investigation, which subjects Israeli  
10          nationals to an investigation for alleged crimes  
11          against Palestinians.

12          (2) In 2021, the ICC opened an investigation  
13          into the “Situation in Palestine”.

14          (3) The chief prosecutor of the ICC recently ap-  
15          plied for arrest warrants for Israeli leaders for a  
16          range of offenses allegedly committed “on the terri-  
17          tory of the State of Palestine (in the Gaza strip)  
18          from at least 8 October 2023”.

19          (b) PROHIBITION AGAINST COOPERATION WITH THE  
20          ICC.—Notwithstanding any other provision of law, no of-  
21          ficial of the United States may cooperate with the Inter-  
22          national Criminal Court with respect to any matter.

23          (c) FULFILLMENT OF STATUTORY CONDITION.—The  
24          investigation referred to in subsection (a)(2) and the ap-  
25          plication for arrests warrants for Israeli officials referred

1 to in subsection (a)(3) justifies prohibiting the use of eco-  
2 nomic support funds for the Palestinian Authority in ac-  
3 cordance with section 7041(k)(2)(A)(i)(II) of the Further  
4 Consolidated Appropriations Act, 2024 (Public Law 118–  
5 47).

6 (d) PROHIBITION AGAINST USE OF ECONOMIC SUP-  
7 PORT FUND IN GAZA.—None of the funds made available  
8 pursuant to chapter 4 of part II of the Foreign Assistance  
9 Act of 1961 (22 U.S.C. 2346 et seq.) may be used to pro-  
10 vide support for the Palestinian Authority.

11 (e) PROHIBITION AGAINST FUNDING FOR THE  
12 ICC.—Notwithstanding any other provision of law, no  
13 Federal funds may be made available for the ICC.
